About **THE COURSE**

This 6-week course combines online learning with Zoom sessions and includes all the requirements from the state-approved operator's course for assisted living and state licensed only adult care homes. In addition to the state-mandated elements, the importance of person-directed living concept of service, dementia and how dementia impacts the lives of elders is covered. This course is convenient and facilitates learning and builds relationships with the faculty and other students. A state-mandated test to become a certified operator will be administered online via Zoom after successful completion of the course. After passing the test, the student is qualified to become the operator of a state licensed only adult care home in Kansas.

Course **STRUCTURE**

This course will be delivered online only with a Zoom meeting on the first and last day of the course. Students will be provided access to the online lessons, course materials, and resources following receipt of your enrollment fee. Activities will consist of discussion forums and email.

To receive your registration to become an operator of an assisted living, residential health care or home plus, you must submit an application and fees to Kansas Department for Aging and Disability Services.

- Payment of applicable fees
- Be at least 21 years of age
- High school diploma or equivalent with one year of relevant experience or have an associate's degree in a relevant field or have a bachelor's degree
